

MŌ TŌ UTU MONI HUA

- Ka utua te moni hua AECT ki te tangata kua whakaingoaia i te nama hiko i te 30 o Here-turi-kōkā 2014. Kāore e taea te whakawhiti ki tētahi tangata kē.
- TE HAKI: Ki te kore koe e āhei ki te whakatakoto i te haki ki te pēke, whakahokia mai me te reta i tae tahi ai, ā, ka utua e mātou te moni ki te kaute hiko.
- TE MONI TĀWERE KI TE KAUTE HIKO: I utua te moni hua hei moni tāwere nō te mea nāu tēnā i tonu, nō te mea rānei koia tonu te tikanga i utua ai koe i tērā tau. Tukua mai koa ētahi wiki ruarua kia puta ai te moni hua i runga i tō nama hiko. Hei tērā tau koe āhei ai ki te tonu haki, ki te tonu moni tāwere utu hāngai rānei ina tuku atu mātou i ngā puka whakahōu.
- TE MONI TĀWERE UTU HĀNGAI: I utua te moni hua ki te tau kaute pēke kua tuhia nei ki te reta. Ki te mea kei te hē tēnei tau, waea ki 0508 AECT INFO (0508 232 846). Mehemea koe i tonu moni tāwere utu hāngai engari i whiwhi haki kē, ko tōna tikanga, i tēnei tau kāore mātou i āhei te tukatuka i tō moni tāwere utu hāngai i tā mātou tukunga atu i ngā puka whakahōu.

有關您的股息支付

- 奧克蘭能源消費者信托基金 (AECT) 于2014年7月30日向電費單上所列客戶支付股息。該股息無法轉讓給他人。
- 支票：如果您無法將支票存入您的銀行帳戶，請將支票連同其隨附信函一并寄回，我們將把股息付至您的電力帳戶。
- 股息存入電力帳戶：遵照您的要求或是依據上一年度的支付方式，股息被存入您的電力帳戶。您可能需要等待數周方能在您的電力帳單上看到所支付的股息。下一年度我們寄出更新表格時，您可以要求以支票或直接存入方式支付股息。
- 直接存入：股息將依照信函上所顯示之帳戶號碼存入該帳戶。如果該帳戶號碼有誤，請致電0508 AECT INFO (0508 232 846)。如果您要求以直接存入方式支付股息，卻收到了一張支票，即表示我們在寄出更

新表格時無法以直接存入的方式向您支付股息。

WHO GETS A DIVIDEND?

Everyone who was an AECT income beneficiary on 30 July 2014 is eligible. Income beneficiaries are people, community groups and businesses who pay Vector electricity line charges (included in your power bill regardless of who your power company might be) in the Trust district of Auckland, Manukau and the northern part of Papakura. The beneficiary is the person with their name on the power bill – so in a rental property this is usually the tenant. CAN I CHANGE THE NAME ON THE CHEQUE?

No. For your security, the dividend cheque is not transferable, so it can't be changed in any way or transferred to another person or name. It must be deposited in a bank account in the same name as shown on the cheque, otherwise it will be dishonoured by the bank. If you can't bank the cheque you can return it and have your dividend credited to your power bill instead. See the form attached to your cheque to find out how.

IS THE DIVIDEND AMOUNT ALWAYS THE SAME?

No. The dividend amount depends on Vector's results each year and the number of people who are eligible to receive the dividend. This year the dividend is \$335.

WHY HAVEN'T I GOT MY DIRECT CREDIT OR POWER ACCOUNT CREDIT YET?

Payments were made on 24 September 2014. If you were expecting a direct credit, check that the bank account shown on the letter is right – call us ASAP if it isn't. If your account number is correct but you haven't received your dividend, please contact your bank as it may be in a bank holding account (UPI). Credit to power accounts will show up on your power bill, but how long this will take depends on your power company's billing cycle.



KEEPING TREES AWAY FROM OVERHEAD LINES KEEPS THE LIGHTS ON

Trees are a major cause of power outages. Last year, one out of every four power cuts on Vector's network was caused by tree branches hitting lines.

In addition to causing outages, overgrown trees also prevent Vector's crews from repairing equipment quickly and delay the process of restoring power to customers.

It's dividend season.

If you're reading this, you've probably just received a \$335 dividend from the AECT.

WHY ARE WE SENDING YOU MONEY?

AECT stands for the Auckland Energy Consumer Trust, the special trust that was set up to own and govern Vector on behalf of consumers who live in the Trust district of Auckland, Manukau and northern Papakura.

Vector is New Zealand's largest energy network, and one of New Zealand's largest companies. As the majority shareholder, the Trust receives a payment every year from Vector's profits. After covering its administration costs, the Trust then pays out what's called a "dividend" to everyone who lives and pays power bills in the Trust district. That means the AECT sends money every year in September to people like you.

This year, your dividend is \$335.

WHY THE AECT INVESTS IN VECTOR

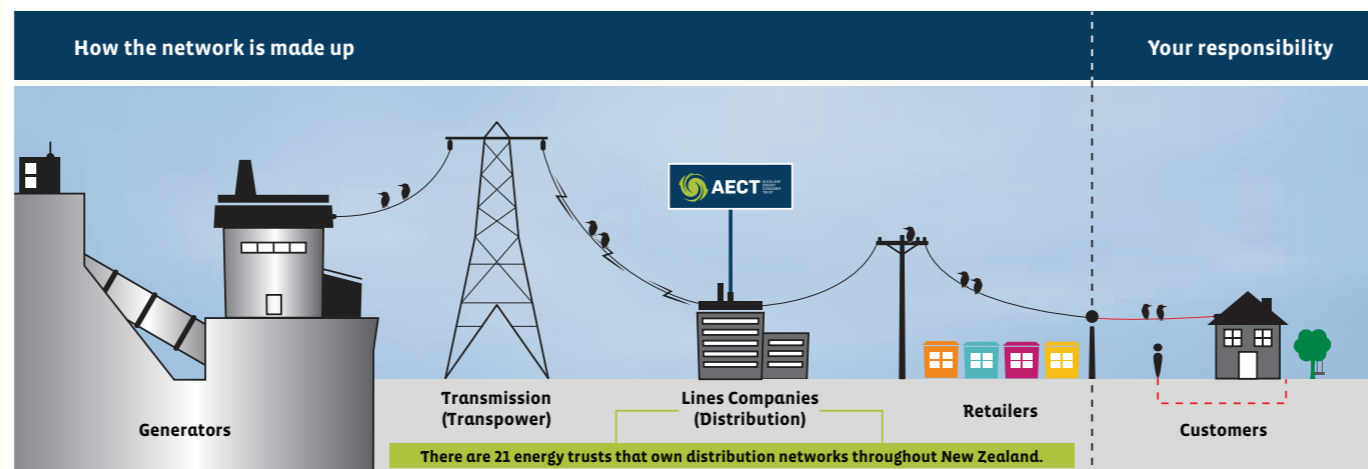
Vector is one of New Zealand's largest infrastructure companies. It has a portfolio of many businesses and operates electricity, gas and fibre optic networks around the country. In fact, Vector provides energy solutions to more than a million Kiwis.

Because Vector is a successful business, each year it distributes part of its profits to shareholders. Since the AECT is the majority shareholder, it receives the biggest slice and shares it with people like you.

A LITTLE MORE ABOUT THE AECT

ABOUT YOUR DIVIDEND PAYMENT

- The AECT dividend is paid to the person named on the power bill at 30 July 2014. It cannot be transferred to another person.
- CHEQUE: If you cannot bank the cheque, send it back with the letter that came with it and we will pay the money to the power account.
- CREDIT TO POWER ACCOUNT: The dividend was paid as a credit because you requested it or that's how it was paid to you last year. Please allow a few weeks for the dividend payment to show up on your power bill. Next year you can request a cheque or direct credit when we send out the update forms.
- DIRECT CREDIT: The dividend was paid to the account number shown on the letter. If this number is not correct, call 0508 AECT INFO (0508 232 846). If you requested a direct credit but received a cheque, it means we could not process your direct credit when we sent out the update forms.

FELĀVE'I MO E TOTONGI ATU 'O HO'O TIVITENI'

- 'Oku totongi atu 'a e tiviteni AECT ki he tokotaha 'oku 'asi 'a hono hinga' 'i he mo'ua 'uhila 'o e 'aho 30 'o Siulai 2014. 'Oku 'ikai lava ke liliu 'eni ki ha toe tokotaha kehe ange.
- SIEKE: Kapau 'oku 'ikai lava ke ke tohu 'a e sieke', fakafoki mai 'eni fakataha mo e tohi na'e 'oatu fakataha mo ia' pea te mau totongi 'a e pa'anga' ki he 'akauni 'uhila'.
- TOTONGI KULĒTITI KI HE 'AKAUNI 'UHILA': Na'e totongi kulēititi atu 'a e tiviteni' koe'uhī he na'a' ke kole mai ke fakahoko 'eni, pe ko e founa ia na'e totongi atu ai 'eni' 'i he ta'u kuo hili'. Kātaki 'o faka'atā ha ngaahi laui uike si'i ke 'asi atu ai 'a e totongi kulēititi ko 'eni' 'i ho'o mo'ua 'uhila'. 'I he ta'u fo'ou', 'e lava ke ke kole ha sieke pe ko ha totongi kulēititi fakahangatonu ki ho'o 'akauni pangikee' (direct credit) 'i he taimi te mau tufaki atu ai 'a e ngaahi foomu ke 'omai ai 'a ho'o ngaahi fakaiiki fakamuimitaha'.

Kapau na'a' ke kole mai ke fakahoko ha totongi kulēititi fakahangatonu ki ho'o 'akauni pangikee' ka na'a' ke ma'u atu 'e koe ha sieke, 'oku 'uhinga 'eni na'e 'ikai ke mau lava 'o fakahoko 'a e totongi kulēititi fakahangatonu ko 'eni' 'i he taimi te mau tufaki atu ai ho'o foomu ke 'omai ai 'a ho'o ngaahi fakaiiki fakamuimitaha'.

배당금 지급과 관련된 안내사항

- AECT 배당금은 2014년 7월 30일 현재의 전기요금 고지서에 기재된 명목자에게 지급됩니다. 수령자를 다른 사람으로 바꿔 지급되게 할 수 없습니다.
- 수표: 수표를 은행에 입금할 수 없을 경우에는 지급 통지서와 함께 수표를 저희에게 반송해 주시면 그 금액을 전기요금에서 공제해 드리겠습니다.
- 전기요금에서 공제: 귀하가 요청했거나 아니면 작년에 이런 방식으로 처리되었기 때문에 전기요금에서 공제하는 방식으로 배당금이 지급되었습니다. 지급 배당금이 실제로 전기요금 고지서에 반영되기까지는 몇 주 정도 시간이 걸립니다. 원하시는 분은 내년에 저희가 업데이트 신청서를 보내 드릴 때 수표나 계좌이체 방식으로 바꿔달라고 요청하시면 됩니다.
- 계좌이체: 지급 통지서에 표시된 계좌번호로 배당금이 지급되었습니다. 이 계좌번호가 잘못된 경우에는 전화 0508 AECT INFO (0508 232 846)로 저희에게 알려 주십시오. 계좌이체 방식을 요청했는데도 수표가 우송되었다면 저희가 업데이트 신청서를 보내 드릴 때 계좌이체 처리를 할 수 없었기 때문입니다.
